

PERFORMANCE CAMPS AT WESTONBIRT SCHOOL

TERMS & CONDITIONS

1. About Performance Camps

Performance Camps provides residential rugby training camps designed to support the physical, technical, and personal development of young rugby players in a safe, structured, and supportive environment. All camps include accommodation, meals, coaching, supervision, and off-pitch activities unless stated otherwise. Performance Camps is a product name within the Westonbirt School product range. All bookings, payments, and contractual arrangements are made with Westonbirt School Ltd. Westonbirt School Ltd is part of Wishford Education Group.

2. Eligibility & Participation

Camps are open to children within the advertised age groups. Participants must be medically fit to take part in rugby and related activities. A completed registration form, medical form, and parental consent must be submitted before attendance. Performance Camps reserves the right to refuse participation if information provided is incomplete or inaccurate.

3. Payments

A non-refundable deposit is required at the time of booking to secure a place. The remaining balance must be paid by the deadline stated in the booking confirmation. Failure to complete payment by the deadline may result in the place being cancelled without refund of the deposit.

4. Cancellation Policy

If a participant needs to cancel the following terms apply:

More than 28 days before the camp start date fees paid excluding the deposit may be refunded. 14–28 days before the camp start date 50% of the total camp fee may be refunded (deposit remains non-refundable). Less than 14 days before the camp start date no refund will be issued. On the event of non-attendance or early departure no refund will be given. All cancellations must be submitted in writing.

5. Camp Cancellation or Changes

Performance Camps reserves the right to cancel or amend a camp due to circumstances beyond reasonable control. If Performance Camps cancels a camp, a full refund will be issued. Performance Camps is not responsible for additional costs such as travel or personal expenses.

6. Health, Safety & Welfare

All staff are appropriately trained and vetted. First-aid provision is available at all camps.

Parents/guardians must disclose all medical conditions, allergies, and medications. In the event of illness or injury, Performance Camps may seek medical treatment where necessary and will attempt to contact parents/guardians as soon as possible.

7. Supervision & Conduct

Participants are supervised at all times during camp activities. A code of conduct applies to all participants. Bullying, dangerous behaviour, or serious misconduct may result in dismissal from the camp without refund. Parents/guardians will be contacted if behaviour concerns arise.

8. Personal Belongings

Participants are responsible for their own belongings. Performance Camps is not liable for loss, theft, or damage to personal items.

9. Photography & Media

At the time of booking, parents/guardians will be asked to state their preference regarding photography and video recording during the camp. Images and footage may be taken during the camp and may be used for promotional and marketing purposes only where consent has been provided. All preferences recorded at the time of booking will be respected throughout the duration of the camp.

10. Data Protection

Personal information is collected solely for camp administration and safeguarding purposes. All data is handled in accordance with UK data protection legislation.

11. Liability

Rugby is a contact sport and carries inherent risks. By booking, parents/guardians acknowledge and accept these risks. Performance Camps' liability is limited to the extent permitted by law.
